## **Welcome and Introductions**

## Approval of Minutes, Sept 3, 2020

Motion was moved to approved meeting minutes from the last meeting and minutes were approved.

#### **Work Plan & Process**

Each work group presented a summary from their first meeting and/or plans to conduct their first meeting. Summaries from all Work Groups follow:

## 1. Community Connections & Social Cohesion Work Group

Keri Gudry presented update

Met Sept. 17th from 6-7

- Added Michael Blackburn and Alderman Feichter to the work group
- Starting from a framework of focusing on support systems of people who are unsheltered and then work to identify gaps
- Team reviewed work group description and goals
- At their first meeting the working group discussed:
  - Visibility of homelessness during this time of covid-19 being exacerbated.
  - Housing first models, where it worked, what it did, and why it worked. Discussed gathering information on communities who have housing first models

Plans for the work group:

- Want to know how many evictions have not made it to the court vet—need numbers
- Identify gaps in mental health needs that are going unaddressed want to add community mental health service provider to group
- Identify gap in detox and in-patient treatment center in Waynesville
- Explore low-barrier shelter to permanent housing continuum gap in these areas
- Substance use and mental health resources for single dads//LGBTQIA+//elderly//registered sex offenders//unaccompanied youth//undocumented individuals
- Create questionnaire for individuals who are homeless to address some of these gaps/barriers, looking into Emergency Solutions (ESG) grant.
- Next Steps: invite homeowners from Hazelwood, Allen's Creek, etc. who can have a discussion—to have better idea about what that looks like

#### 2. Economic Stability Work Group

Alderman Sutton presented update

Read attendee list

Invitations extended for Stephanie Sutton and Brian Cagle to join Met 9/15 @ Grace Church

- Discussed impact of homelessness on businesses//questionnaire for businesses being developed
- Clarification on loitering—someone cannot currently be arrested for loitering although they can be asked to move (get clarification from law enforcement on this)
- Low-barrier shelter—Gap Identified

- Want to do a point in time count immediately
- Want to research effectiveness of low-barrier shelters in other municipalities
- Want data from Maggie shelter

## 3. Education Work Group

Bob presented updates

Meeting planned this coming Monday 9.28.20 at 7:45am

- Discussed providing life skills education to people who are homeless
- Substance use prevention in schools and long-term planning/thinking
- Safe Dates—dating safely program
- Bringing the broad spectrum into detail will be the goal of first meeting
- Alderman Dickson will be joining

# 4. Eviction, Foreclosure, Crisis Response and Winter Preparation Work Group

Commissioner Ensley and Vicky presented

Met 9/17 on zoom

- Wanted to identify resources for renters and subsequently, made resource list
- ABCCM—identify federal funding for veterans
- Other supports available from Disability Partners, Salvation Army and Mountain Projects
- In addition, Haywood Christian ministries has shifted from offering heating assistance to providing more food through Manna foodbank
- Stated when people have food resources they do not need as much assistance with utility and rent
- Michelle Rogers also attended—manages rentals in county—1% eviction rate through this time. Provided insight into landlord and tenant issues.
- How to help landlords and renters will be one focus of group
- Work Group also wants to assist with Winter Preparation

# 5. Health Work Group

Juleah update

Met 9/16/20 from 5-6

The Work Group is addressing mental health, physical health, & substance use issues.

 Conversation about gap identification: discharge from jail and prison, especially if people are incarcerated elsewhere but from Waynesville and brought back here. In addition, there is a lack of some mental health services with the closing of Balsam Center.

- Further, when people needed services, they may be difficult to access due to having assessment conducted at multiple agencies, lack of transportation and access to a low barrier shelter.
- Brainstormed gaps and identified providers from whom data will be requested (including, local substance use and mental health treatment providers-- i.e. how many people who are homeless are accessing services)
- Gap in lack of transitional housing

Next meeting scheduled 10/5/20 from 5:30-6:30pm

#### **OPEN DISCUSSION POST WORKING GROUP PRSENTATIONS:**

- Discussed housing continuum of care with multiple entry points, i.e. low barrier shelter, to longer term shelter, to transitional housing, to affordable housing.
- Discussed low barrier shelter—Kasey Valentine updated TF on shelter said she would connect with members of a local homeless coalition to provide summary and outcome data to the TF.
- Discussed talking to Scottish Inn hotel owners and inquiring about their occupancy—the Scottish Inn is for sale. Decent location. 1 million. \$750,000---trying to bring down to \$650,000. 21 rooms. Apartment in the middle of the unit.
- Discussed point in time count—Joslyn suggested doing one before January.
- Peer support in jail working with people transitioning.
- Tyler, with the Town of Waynesville Police Department, reported 6 homeless encampments within Waynesville city limits
- A discussion involving privacy concerns was raised in how to address information regarding homeless encampments and other sensitive information in meetings.
