#### **Welcome and Introductions**

Chair Amy Murphy-Nugen opened the meeting and welcomed Task Force and community members; the meeting was hybrid both in-person and online via Zoom. Chair Amy Murphy-Nugen opened space for people to introduce action items. Brandon W. introduced a resource and outreach idea including backpacks filled with sleeping bags, hygiene, and other items that may be useful for people experiencing homelessness. Brandon shared that Veteran's Services has some funding to use to purchase items to fill outreach backpacks and suggest that as an action items that the Task Force take on. He shared there is funding for Veteran's and non-veterans to receive outreach bags. Mandy shared updates on the 'Holy Cow' food truck. Joslyn reported on a conversation with a property owner in Frog Level she had recently in which he was highly

frustrated and upset about property destruction. Dale shared property crime in Allen's Creek has become an issue due to people breaking into overgrown homes. Chair Murphy-Nugen thanked members for sharing this feedback and encouraged folks to think about how working groups might respond.

#### Approval of Minutes, August 20, 2020

Joslyn motioned to approve the minutes, and the motion was approved.

#### **Work Plan & Process**

Chair Amy Murphy-Nugen and other members provided the following updates: Hannah will be working with ABCCM in Haywood and provide outreach/case management services to people experiencing homelessness.

Chair Amy Murphy-Nugen provided a CDC update on a new eviction moratorium notice. Tenants who are being evicted can sign a statement for protection. More information will be provided September 4, 2020 from the CDC. Chair Murphy-Nugen has a meeting set up to speak with Alderman Feichter to plan a listening session for neighbors who are being impacted by homelessness in the community/neighborhood.

An NC Care 360 update was provided and Chair Murphy-Nugen offered to connect people to NC Care 360 if they have an interest. A suggestion was made that the Task Force consider promoting NC Care 360 to providers in Waynesville and Haywood and encourage its use in the community.

The Task Force discussed working groups and narrowed the 9 groups that had been identified into 5. No group was dissolved, and 4 groups were combined into other existing groups. The five working groups include:

- 1. Health (includes physical, mental/behavioral health—including substance use)
- 2. Economic Stability (business support, employment/income support—amended to include affordable housing)
- 3. Community and Social Connection (homeowner support, support systems, social cohesion—amended to include veteran support)
- 4. Education (prevention, early intervention)
- 5. Eviction & Foreclosure // Crisis Response // Winter Preparation

Task Force members and community members in attendance split into working groups. Members were assigned according to the interest they identified at the last meeting.

After breaking into work groups for approximately 40 minutes and answering introductory questions, working groups then came back together and reported leads, when they are meeting, who will serve as note taker, and who currently is participating on each work group:
